Anyone with a positive result will be required to go home immediately. The person is required to isolate for IO days from the date of the positive LFT (with the test date being day O). The legal duty to self-isolate is triggered by a positive LFT. It is also necessary for the setting to isolate any close contacts of the case for the 48 hours prior to the LFT test being conducted. | Manage positive cases amongst the school community | School Head Teacher | COVID 19 | Schools must take swift action when they become aware that someone who has attended has tested positive for coronavirus (COVID-I9). Schools should contact the local health protection team. This team will also contact schools directly if they become aware that someone who has tested positive for coronavirus (COVID-I9) attended the school — as identified by NHS Test and Trace. The health protection team will carry out a rapid risk assessment to confirm who has been in close contact with the person during the period that they were infectious, and ensure they are asked to self-isolate. The health protection team will work with schools in this situation to guide them through the actions they need to take. Based on the advice from the health protection team, schools must send home those people who have been in close contact with the person who has tested positive, advising them to self-isolate for IO days since they were last in close contact with that person when they were infectious. Close contact means: Direct close contacts – face to face contact with an infected individual for any length of time, within I metre, including being coughed on, a face to face conversation, or unprotected physical contact (skin-to-skin). Proximity contacts – extended close contact (within I to 2 metres for more than I5 minutes) with an infected individual. Travelling in a small vehicle, like a car, with an infected person. The health protection team will provide definitive advice on who must be sent home. To support them in doing so, we recommend schools keep a record of pupils and staff in each group, and any close contact that takes places between pupils and staff in different groups (see section 5 |

Schools do not need to ask pupils to record everyone they have spent time with each day or ask staff to keep definitive records in a way that is overly burdensome. Household members of those contacts who are sent home do not need to self-isolate themselves unless the child, young person or staff member who is self-isolating subsequently develops symptoms. If someone in a class or group that has been asked to self-isolate develops symptoms themselves within their IO-day isolation period they should follow 'stay at home: guidance for households with possible or confirmed coronavirus (COVID-I9) infection'. They should get a test, and: If the test delivers a negative result, they must remain in isolation for the remainder of the IO-day isolation period. This is because they could still develop the coronavirus (COVID-I9) within the remaining days. If the test result is positive, they should inform their setting immediately, and must isolate for at least IO days from the onset of their symptoms (which could mean the self-isolation ends before or after the original IO-day isolation period). Their household and support bubble should self-isolate for at least IO days from when the symptomatic person first had symptoms, following 'stay at home: guidance for households with possible or confirmed coronavirus (COVID-I9) infection' Schools should not request evidence of negative test results or other medical evidence before admitting pupils or welcoming them back after a period of self-isolation. If schools are implementing controls from this list, addressing the risks they have identified and therefore reducing transmission risks, whole school closure based on cases within the school will not generally be necessary, and should not be considered except on the advice of health protection teams. |

Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or difficulty in breathing, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area (the meeting room) where they will not come into contact with others and are supervised at all times (supervising member of staff to wear full PPE) The relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen. The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff. Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance. Unwell pupils who are waiting to go home are kept in an area (the radio) where they can be at least two metres away from others. Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces. If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection. |
